3.	Regular Candidates who have completed their education qualifications during the years 2023, 2024 & 2025 are only eligible to apply.
4.	Candidates with post graduate qualifications are not eligible to apply.
5.	Candidates who have already undergone Apprenticeship Training or at present undergoing Apprenticeship Training under any organization are not eligible to apply.
6.	Candidates with more than one-year work experience are not eligible to apply.
7.	Candidates should not be less than 18 years of age as on closing date of application.
