1.1 About the Institute

The National Institute of Social Defence (NISD) was set up originally as Central Bureau of Correctional Services in 1961, under the Ministry of Home Affairs. The Bureau was later transferred to the then Department of Social Security in 1964. Since 1975, the Institute has been functioning as a subordinate office under the erstwhile Ministry of Welfare (now Ministry of SJ&E). It became an Autonomous Body vide Government of India's Notification No. 10-3/2000-SD.Vol.II dated 15th July, 2002 and is registered under Societies Registration Act, XXI of 1860, with the Government of NCT of Delhi.

The National Institute of Social Defence is the Nodal Institute for training and research in the field of social defence. The Institute is focused on the issues of human resource development in the areas of substance abuse prevention, care of older persons and other social defence issues.

1.2 Mandate:

The mandate of the Institute is to create awareness on social defence issues of the Government of India. The Institute achieves this through sensitization, orientation and capacity building programmes conducted in collaboration with various organisations of the State, Regional, National & International level.

1.3 Objectives:

The main objectives of the Institute are as follows:

 develop preventive, rehabilitative and curative policies in the field of social defence;

- ii. review policies and programmes in the field of social defence;
- iii. anticipate and diagnose social defence problems;
- iv. identify and develop the instruments for realizing the objectives of social defence policies;
- v. develop and promote voluntary effort in the areas of social defence.

1.4 Areas of Concern:

The major areas of intervention are as under:

- i. Substance (Drugs)Abuse Prevention
- ii. Care of Older Persons and
- Other Social Defence issues including Beggary Prevention, transgender welfare etc.

1.5 Target Groups:

The target groups of the Institute are:

- i. Functionaries of RRTCs and IRCAs(Drug Rehabilitation Centres)
- ii. Functionaries of concerned social welfare departments in Government and other stakeholders working in drug (substance) abuse prevention/old age care.
- iii. Field and middle level Police functionaries through State Police Academies.
- iv. Persons to work as geriatric caregivers.
- v. Students/NSS volunteers/teachers in Universities/Colleges/Schools through sensitization programmes.

1.6. Organizational Set-up:

The Institute is headed by a Director and has the following Divisions:

- i. Administration and Planning
- ii. Drug (Substance) Abuse Prevention
- iii. Old Age Care
- iv. Other Social Defence Issues and
- v. Media, Publication & Coordination

The Organizational Chart of the Institute is placed at **Annexure-I.**

1.7. Councils:

(i) General Council

The General Council is the apex governing body of the Institute with the Secretary, Ministry of Social Justice and Empowerment as its ex-officio President. Other members of the Council, are representatives from concerned Central Ministries/ Departments and experts/ professionals in the areas of social defence. The Council lays down the broad policy framework for the Institute.

(ii) Executive Council

The Executive Council is headed by the Joint Secretary (Social Defence), Ministry of Social Justice and Empowerment, Government of India. Other members of the committee are Director/Deputy Secretary (I F wing), Director, NISD, and two Non-official members. The Council monitors and guides the activities and programmes of the Institute.

1.9 Construction of the Institute Building at Dwarka :

The Institute, since its inception is functioning at West Block-1, Wing-7, R. K. Puram, New Delhi. The Delhi Development Authority (DDA) has allotted 2 acres of land at Sector 10, Dwarka, New Delhi to the Institute for construction of institutional building with facilities for residential training programme. CPWD is the nodal agency for construction of the Building. The detailed cost estimate as worked out by CPWD comes to Rs. 62.42 cores for construction of a six storey building. The Institute has upto 31/03/2017 deposited an amount of Rs.32.96 crores with the CPWD for the construction of the building. The construction is likely to be completed by the end of 2017.

2.1 Budget Allocation:

The NISD plans its activities within the allocated budget, received in the form of Grant-in-Aid (GIA) from the Ministry. A Budget of Rs.22crore (Plan) and Rs.2.93crore (Non

2.5 Media Division

The Institute participated in some important public events *viz*. Shilpotsav at Dilli Haat, New Delhi and India International Trade Fair, Pragati Maidan, New Delhi to promote preventive education and create awareness about ill effects of alcoholism & drug abuse and activities of the Institute. 3.1 Organization and Management

The National Institute of Social Defence is governed by its Bye-laws, which came into force w.e.f. 23rd May, 2013. To facilitate smooth functioning and to create a congenial work environment of the Institute, there is a multilevel support structure. Director, NISD is the Head of Department. He is supported by Deputy Director(Admn. & Plg.) who is the Head of Office, and 03 other Dy. Directors, who are heading various programme divisions. In addition, there is a General Council (GC) and an Executive Council (EC).


The General Council (GC) consisting of 12 members (08 official and 04 non-official) is the apex governing body of the Institute with the Secretary, Ministry of Social Justice and Empowerment, as its ex-officio President. For effective functioning and better coordination, the GC was reconstituted in September, 2016 by downsizing its composition to 12 members from the earlier 20 members. Official members of the GC are representatives from concerned Central Ministries/ Departments and the non-official members are experts/professionals in the areas of social defence. The GC of the Institute was reconstituted vide Ministry of Social Justice and Empowerment's Order No.50/19/2004-Admn, 28/09/2016 for a period of two years whose composition is given at **Annexure – II.**

The Executive Council, consists of 05 members (03 official and 02 non-official). EC is headed by the Joint Secretary (Social Defence), Ministry of Social Justice and Empowerment, Govt. of India. The EC was also reconstituted in July, 2016 vide Order No. 50/13/2011-Admn, dated 11/07/2016 dated July.2016 for a period of two years whose composition is given at **Annexure-III**.

While the GC lays down the broad and essential policy parameters, the Executive Council (EC) monitors and guides the activities and programmes of the Institute.

3.2 Structure of the Division

The Dy. Director (Admn. & Plg.) of the Institute is the administrative head of the Division. The Organization Chart of the Division is given as under:



3.3 Implementation of Official Language Policy

With a view to promote the use of Official Language in the working of the Institute, an Official Language Implementation Committee has been constituted under the chairmanship of the Director of the Institute.

During "**Hindi Pakhwara**" from 1st to 15th September 2016, a number of events were organized including competition in Hindi typing, noting and drafting, Poetry etc., and the best performers were given cash awards. On the conclusion of the "Hindi Pakhwara", a workshop was organized to discuss steps required to be taken by the Institute for promoting use of Official Language.

3.4 Implementation of Right to Information Act, 2005

The Institute has been implementing the Right to Information Act, 2005 since October, 2005. Dy. Director (SD) of the Institute is the Central Public Information Officer (CPIO) and the Director is the First Appellate Authority.

3.5 Funds

The Institute is primarily supported through Grant-in-aid (GIA) released by the Ministry of Social Justice and Empowerment. During the year 2016-17, the Institute received GIA of Rs.4.50 crore under Plan for programmes and activities, and Rs 2.93 crore was received under Non-Plan. Total expenditure incurred under both Plan and Non-Plan is Rs. 6.99 crore.

3.6 Accounts and Audit

The accounts were maintained on accrual system of accounting, as provided in the Bye-Laws of the Institute. The internal audit of the annual accounts of the Institute was undertaken by CAG empanelled Agency namely M/s Krishna Kumar & Associates, New Delhi for the year 2016-17. Copy of duly audited statement of Annual Accounts of the Institute for the year 2016-17 and general views of Office of the Addl. Dy. C&AG (Central Expenditure) on the overall Accounting system as received vide DG(Audit) C&E letter no. AMG-1/I.R/03-13/NISD/2018-19/1014 dt. 09/01/2019 are at **Annexure IX.** Drug abuse has become a worldwide problem in modern times. Today, there is no part of the world that is free from the curse of drug trafficking and drug addiction. Drug means a habit-forming substance which is taken pleasure or excitement and which induces sleep or produces insensibility. Youth and teenagers are more prone to become the victims of drug abuse. Illegal production and distribution of drugs have spawned crime and violence worldwide.

Drug abuse manifests itself in euphoric behavior by the user – and at most times unnaturally so. This leads to a sequence where the users keep on repeating the same action of drug abuse. When this pattern continues the brain tries to adapt to the usage by reducing its own dopamine production as well as dopamine receptors. The user tries to adapt to this through drug abuse so that his or her dopamine production level can be brought back to a level that seems normal to him or her.

Prevention is one of the ways in which drug abuse can be dealt with. In fact it is one affliction that can be prevented according to medical experts and practitioners. Prevention programmes involving entities such as families, schools, drug treatment centre functionaries and also the immediate communities are important in this regard. The Sustained treatment is the option for people who have already gone down the road of drug abuse and are highly into it. The treatment for a drug abuser normally depends on the kind of drug that the person has been using. It is said that the best treatments normally emphasize on phenomena related to the individual's life. This includes areas such as medical, psychological and work-related needs as well as issues in relationships with other people in the person's life. The treatment sessions combine medication and behavioral therapy so that the victim of drug abuse gradually stops feeling the urge to do drugs. These treatment programmes also impart the skills and capability required in order to say no to drugs in the future, which is highly critical for a complete cure to drug abuse.

In view of the growing threat of substance abuse and its impact on the nation, it was decided to give the then Bureau of Substance Abuse Prevention in the Institute a broadened role by setting up a National Centre for Drug Abuse prevention (NC-DAP) in September, 1998. The mandate of the unit is to provide technical support to the Government on policies relating to substance abuse prevention and facilitate a wider and improved coverage of services throughout the country for substance demand reduction.

The Drug Abuse Prevention is one of the core concerns of the Institute and through NC-DAP, the Institute has been able to expand its activities and has worked out strategies for tackling the issues of substance abuse and bring about qualitative improvements in service delivery. It has evolved a strategy for the capacity building of the service providers through a series of training and orientation courses. To formulate effective intervention modules and programmes, impetus has been provided to research and documentation activities to develop deeper insight into the problem and collection of information on extent, trends and patterns of drug abuse through feedback from the field.

4.2 Aims and Objectives

It is the endeavor of the Institute to achieve the following:

- Raising the competency standards of the functionaries/ personnel working in substance demand reduction and other related sectors;
- ii. Standardization of care in substance abuse prevention;
- iii. Updating information and creating a database on extent and pattern of substance abuse and interventions developed at local, regional, national and international levels; and
- iv. Promoting advocacy and networking in the field of substance abuse prevention.

4.3 Target Groups

The Institute primarily caters to the training requirements of functionaries /service providers working in the treatment and rehabilitation centres supported by the Ministry of Social Justice and Empowerment viz. project co-ordinators, counselors, social workers, out-reach workers, community workers, nurses and ward boys. The Institute also conducts capacity building programmes for school teachers/ NSS Volunteers/ MSW Students, and awareness programmes for Schools/ Colleges/ Universities on the ill effects of drug abuse.

4.4 Activities:

The main activities in the field of drug abuse prevention are :

- Capacity building of various levels of functionaries working in the field of drug demand reduction;
- (ii) Conducting awareness programmes in

schools/colleges/universities on ill effects of Alcoholism & Drug Abuse;

(iii) Development of linkages, facilitating advocacy, and promoting networking arrangements in the field of drug demand reduction at Local, Regional, National and International levels.

4.5 Awareness and Capacity Building Programmes:

A total of **267** training courses/ sensitization programmes/ consultations/ capacity building courses, covering **17059** persons were organised by NCDAP Division of NISD in collaboration with RRTCs, Universities and other collaborating agencies during the year 2016-17. List of programmes is at **Annexure-IV**. The list of RRTCs including the details of contact persons, States covered is at **Annexure – V**. Further details of the programmes are as follows:

> (i) Three Months Certificate Course on "Drug Deaddiction Counselling and Rehabilitation"- The course is designed for Project Officers, Senior Counsellors and NGOs functionaries working in Treatment-cum-Rehabilitation Centres. The training course includes two months of classroom training and one month of field placement in selected treatment centres. The broad content of the course is in form of eight learning units - Basics of Addiction. Counselling Treatment Protocols, Awareness Creation and Preventive Education, Rehabilitation, Relapse Prevention and Aftercare Services, and Record Keeping and Documentation.

(ii) One-Month Basic Course on "Substance Abuse Prevention has been designed to build the knowledge base of interested, students and graduate service providers including Counsellors, Social Workers, **Outreach Workers of treatment** centers. The course includes interactive theoretical sessions and one week field placement in reputed treatment centers. The broad contents of the course are - Basics of Addiction, Motivation and Counselling, Community Based interventions, Outreach and Awareness Creation.

(iii) Capacity Building programme on Drug Abuse Prevention for School Teachers, MSW and NSS students / volunteers organized in collaboration with various Central Universities of India. Total 21 programs covering 636 beneficiaries were organized during the year.

5 Days Training programme on counseling for IRCA functionaries organised by Association for Voluntary Action (AVA) RRTC East- III

- Substance Addiction Identification, Initial Motivation and Early Intervention: to orient service providers on symptomatic behaviour, early identification and early warning signs so as to equip them with requisite techniques for early intervention.
- Counselling Skills & Techniques Individual Family and Group: to train counsellors working in the areas of substance demand reduction so as to expand their knowledge base & sharpen their individual, group and family Counselling skills.
- Rehabilitation and Relapse
 Prevention Issues & Modalities: for service providers for development and implementation of rehabilitation and relapse prevention programmes.
- Prevention and Management of Substance (Drugs) Abuse and HIV/ AIDS: to orient and expose the service providers to the area of HIV/AIDS

prevention among substance users.

- Documentation for Addiction Management-Assessment, Client Profiling, Recording and Documentation: to ensure proper recording and documentation of programme activities.
- Alcohol and Substance Abuse Prevention: to sensitise welfare officers, project officers, counsellors and other functionaries of drug treatment centres, service providers of these areas

(viii) Strategic Consultations

The Institute also organizes strategic consultations with various stakeholders to evolve strategies for convergent action so as to bring synergy in ongoing programmes of different partners.

The Institute also held Annual Consultative Meet with twelve Regional Resource and Training Centres (RRTCs), located in different parts of the country which serve as regional extension centers. This consultative meet is organized each year to plan out the activities of NC-DAP and RRTCs for strategizing key interventions based on emerging trends, evidence and experience gained at the operational level.

4.6 Drug Abuse Monitoring System (DAMS):

Drug Abuse Monitoring System (DAMS) is an online data base application wherein data on the types of drugs (substance), mode of consumption, clinical and general profile of treatment seekers at de-addiction centres etc is collected for understanding the trends of the substance abuse in the country. DAMS has become operational since February, 2016. This system would be useful for developing appropriate drug abuse preventive strategies. The data on drug patients profile are being fed by drug treatment cum rehabilitation centres supported by Ministry through online DAMS regularly.

4.7 Other Important Events

5.1 Background

The world is witnessing an unprecedented demographic transition in elderly population. The proportion of 60+ population is on the rise. The phenomenon caused by increased longevity and decreased mortality has surfaced in developing countries rather swiftly as compared to the developed ones. Increased number of elderly population is not just a challenge to meet their specific needs but also presents an opportunity as well to draw upon the vast repertoire of their experience and knowledge.

As per 2011 Census of India, total population of senior citizens (60+) is 10.38 cores which is 8.6% of the total population of the country.

The projected population aged 60+ and their percentage share in the total projected population of country, for the year 2016 to 2026 as per 2006 report of the Technical Group on population projections constituted by the National Commission on population published by the Registrar General of India is as under:

5.2 Aims and Objectives

In pursuance with the National Policy on Older Persons (NPOP), the National

Institute of Social Defence is developing a dedicated cadre of Geriatric Caregivers and generating skilled manpower, with focused attention on training for intervention in the family and community settings. The younger generation and others concerned with the welfare of older persons are encouraged to attend to the needs of the older persons.

5.3 Target Group:

The main Target group is functionaries of Old Age Homes/ Day Care Centres, etc., supported by the Ministry / State and the persons willing to work as geriatric care givers. The Institute also conducts awareness programmes in Schools/ Colleges/ Universities on issues of Old Age and for Promoting Inter-generational bonding with the help of Government/NGOs/ policy makers etc working in the field of ageing.

5.4 Awareness and capacity building programme:

During the year 2016-17, Old Age Care division conducted **84** programmes covering **4171** beneficiaries. The detailed list of programmes is at **Annexure-VI.** The list of RRTCs (Old Age Care)/ Collaborating agencies is at **Annexure VIII**. Further details of the programmes is as follows: .

5.4.1. PG Diploma in Integrated Geriatric Care

The main focus of the programme are as follows:

- To develop a cadre of professionals at Managerial/Supervisory level for the care and welfare of the senior citizens;
- To provide a comprehensive and

scientific knowledge base on various aspects relating to geriatric care;

- To develop an appropriate aptitude and skill for working with older persons.
- To orient the students on various techniques of understanding and working for the welfare of the elderly with focus on programme development and management.

The training course includes theoretical sessions, practical sessions, field visits, internship and project work. In addition, seminar presentation and submission of dissertation based on field work are other essential parts of the course. Annually Rs. 3000/- course fee was charged from the students. The course was conducted by NISD in New Delhi.

5.4.2. Six months Certificate Course on Geriatric Care

The main focus of the programme are as follows:

- To train in supervisory management skills.
- To work with geriatric nurse assistants.
- To coordinate variety of programmes in institutions.
- To train the cadre to perform as assistants to management.
- To guide the geriatric assistants in



delivering the services.

5.4.3. Three months Certificate Course in Geriatric Care for Bedside Assistance/ Caregivers

The main focus of the programme are as follows:

- To develop a cadre of trained bedside assistants for care of elderly in institutional and non-institutional settings.
- To improve the quality of care to the elderly through bedside assistants with good nursing skills.

During the year 2016-17, **683** students had undergone geriatric care givers course. No course fee was charged from the students.

5.4.4. Five Days Training Programme on Geriatric Care

The main focus of the programme are as follows:

- To ensure the Rights and dignity of the elderly through ethical care giving practices by developing knowledge on basic components of geriatric care among the staff of OAH/DCCs;
- To Enhance knowledge of Geriatric Counselling and Geriatric Rehabilitation among the staff of OAH/DCCs ;
- To Facilitate quality services in the Old Age Homes by developing skills for

resource management and networking among the staff of the institution ;

 To Expose the staff of OAH/DCCs to field situations and innovative approaches in the Ageing;

- To Build comprehensive knowledge base on dementia among the staff of old age homes/day care centers;
- To Facilitate effective and ethical management of dementia by developing communication and resource management skills among the staff of old age homes/day care centers;
- To preserve the Rights and dignity of the senior citizens with Alzheimer's Dementia living in Old Age Homes/Day Care Centers;
- To Expose to field situations and innovative approaches in the Ageing;


5.4.6. One Day Sensitization Programme on Promoting Inter-generational Bonding in schools/colleges for students/school teachers/counsellors/parents/grand parents

Other Social Defence Issues

6.1 Background:

Social Defence is understood in common parlance pertains to certain marginalized population group requiring protection as well as care and support through systematically organized and coherent efforts both by Government and Civil Society. Social Defence issues such as Drug Abuse, Old Age, Beggary, Transgender, HIV/AIDS, trafficking, etc. are the emerging concerns. Therefore the efforts for well-being of those sections of the society which are affected is vital and requires immediate and suitable interventions.

Beggary is serious problem in India which needs to be addressed on priority. Laws against vagrancy and beggary are a means of control over such persons, who constitute a source of potential threat and annoyance to society. However, the problem is more of a social issue & needs to be handled accordingly. Systematic training/sensitization Programmes for the concerned State officials and NGOs partners on beggary prevention would go a long way in eradication of this social evil.

Transgender community is one among the most weakest and vulnerable communities in India. They face high levels of stigma in almost every sphere of their life health, schools/colleges, such as employment, social schemes and entitlement. Extreme social exclusion diminishes self-esteem and sense of social responsibility. The community needs to be included in the mainstream development program of the country and be protected from all forms of abuse and exploitation. The Social Defence Division assists the Ministry for Conducting consultation meets, workshops,

inter-ministerial meetings on transgender for chalking out Policies, legislations and developmental schemes/programs for Transgender Community. In addition, the Division organizes skill development training programme for transgender community to which enables them to lead life worth living.

The Division also looks after the matters related to issues relating to children affected by drug abuse and counselling skills for the stakeholders in the field of Social Defence. The Division also trains Govt./ NGOs/ Panchayati Raj /Police functionaries and Social Work professionals on Social Defence issues through three days State and Regional level programmes.

6.2 Aims and Objectives

The basic aim of the Division is to establish links with State Police Academies and Social Welfare Departments and Institutions working in the areas of Beggary Prevention and other Social Defence issues for imparting training to stakeholders/service providers. Its Objectives are:

- Sensitization of stakeholders and the community towards the issues of the vulnerable group including beggars and transgender persons;
- Development of welfare schemes and conduction of programmes for such marginalized groups.

6.3 Target Groups

The target groups of the Division is officials of concerned State Social Welfare Depts., middle level functionaries of State Police Departments, field supervisors of Social Work Institutions, concerned NGO functionaries, Social Workers and Panchayati Raj Functionaries.

6.4 Activities

The following are the activities of the Division:

- Capacity building of various functionaries working in area of other Social Defence issues including Beggary Prevention and Transgender;
- Sensitizing Government officials, Police functionaries, Panchayati Raj functionaries, NGO Functionaries, and social workers in the areas of Social Defence Issues;
- Skill development training program for transgender and beggars with prime objective of enabling them to acquire required skills resulting in their dignified life worth living
- Research and documentation in the areas of other social Defence issues; and
- Organising national level seminars and consultative meets on the issues related to Social Defence.

6.5 Awareness and Capacity Building Programme:

During the Financial year 2016-17, the Social Defence division conducted 223

programmes covering 17,028 beneficiaries. The details of programmes is at **Annexure VII**. Further details of the programmes are as follows:

6.5.1 Thematic Skill Building Programmes

The following short term thematic programmes were organised by the Division:

Three Days Training Programme for Government/ NGO/ Panchayat functionaries on Social Defence **Issues** aims at sensitizing and orienting participants on Social Defence Issues to develop knowledge and understanding of concepts, legislations, programmes, schemes of Social Defence and the roles and responsibilities of different personnel and agencies in the successful implementation of Social Defence Programme of the Govt. of India.

Three Days Training Programme for the functionaries of Police Department on Social Defence Issues aims at sensitizing and orienting participants on Social Defence Issues and equips the officers with understanding of the different provisions of laws and programmes, and their responsibilities in the Social Defence domain.


Media and Publicity


